Liquid accelerator for protecting freshly applied products on the basis of bitumen emulsions from rain

Features

KÖSTER BE Rainproof forms a water-resistant film on all fresh bitumen emulsions (KÖSTER Bikuthan[®] 1C Supertight and 2 C Supertight, KÖSTER Deuxan[®] 1C and 2 C Extratight, KÖSTER KBE Liquid Film, KÖSTER Bitumen Emulsion). It reduces the setting time of these coatings and trowel masses. It protects the coatings from rain.

Technical data

Active ingredients	inorganic salts
Concentration of active ingredients	12 %

Field of application

KÖSTER BE Rainproof is used as protection from rain for freshly applied products on the basis of bitumen emulsions.

Application

KÖSTER BE Rainproof is sprayed onto the freshly applied coating using a fine nozzle (e.g. garden spraying device). If the fresh coating is expected to be exposed to a long lasting and heavy rainfall, then protect it additionally with plastic foil.

KÖSTER BE Rainproof must only be applied to the finished waterproofing – it may not be applied to intermediate layers.

Consumption

Approx. 200 g / m²

Cleaning of tools

Clean tools immediately after use with water.

Packaging

5 kg canister

Storage

Store the material in a cool and frost free place; in originally sealed packages, the material can be stored for approx. 2 years.

Safety precautions

Wear protective gloves and goggles when processing the material.
